

**AMENDMENT TO BOARD OF SUPERVISORS  
AGREEMENT NO. 20-077**

This Amendment to BOS Agreement No. 20-077 is entered into this 22<sup>ND</sup> day of JUNE, 2021, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Liebert Cassidy Whitmore, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 20-077 was entered into on June 10, 2020; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Liebert Cassidy Whitmore, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 20-077, from June 30, 2021 to September 30, 2021; and

WHEREAS, CONTRACTOR and COUNTY agree to amend BOS Agreement No. 20-077 in the amount of Fifty Thousand Dollars (\$50,000) for services to be provided through September 30, 2021, for a contract total of One Hundred Ninety Two Thousand, Five Hundred Dollars (\$192,500)

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 20-077 will be extended from June 30, 2021 to September 30, 2021.
2. To amend BOS Agreement No. 20-077 in the amount of Fifty Thousand Dollars (\$50,000) for services to be provided through September 30, 2021, for a contract total of One Hundred Ninety Two Thousand, Five Hundred Dollars (\$192,500)

All other terms and conditions of BOS Agreement No. 20-077 shall remain in full force and effect.
